

Beaver Emergency Services Commission (BESC)



Overview:

The Beaver Emergency Services Commission (BESC) is a partnership between Tofield, Ryley, Holden, Viking, and Beaver County for the provision of fire protection and emergency management (disaster) services to member municipalities.

The fire service consists of six fire stations, 8 Pumpers, 2 Rescue, 3 Tankers, 7 Mini Pumpers, 2 Utility Vehicles, and 110 firefighters responding to 300+ emergencies annually. BESC employs a regional Emergency Manager and administrative assistant with headquarters located in Viking.

Emergency Management focuses on maintaining a regional Emergency Management Plan that will ensure effective utilization of resources on a regional basis rather than deployment of manpower and equipment from individual municipalities. The Director of Emergency Management ensures continuity is maintained combined with progressive updates to the regional Emergency Management Plan.

Mandate:

To provide administration and overall operation of fire and emergency management services for partner municipalities within Beaver County.

Beaver Foundation



Overview:

Beaver Foundation was established in 1960 to construct and operate a seniors' lodge in Viking, with the original partnering municipalities of Beaver County, Viking, and Ryley. The Town of Tofield joined the Board in 1976, and the Village of Holden joined in 1983 when their lodges were constructed. In 1995, the Foundation also assumed control of the seniors' self-contained facilities within the Beaver County region.

The Board consists of five members – one Councillor from each participating municipality.

Mandate:

The Board's Mission Statement for the seniors' lodges is "... provision of accommodation in a home-like atmosphere for senior citizens, offering daily aids to living of the senior citizens in conjunction with other public service agencies, and offering opportunities for residents to participate in leisure, recreation, and social activities which foster their continuous involvement in family and community life".

The Board's Mission Statement for seniors' manors is "... provision of basic independent accommodation and maintenance services in a home-like atmosphere for senior citizens and low-income tenants".

Beaver Regional Partnership (BRP)









Overview:

Over the last few years, the municipalities in the Beaver County region have enjoyed increased intermunicipal cooperation and partnerships. In September 2010, in keeping with the spirit of continued dialogue and cooperation, each municipality agreed to membership in the Beaver Regional Partnership to discuss and implement matters of mutual regional interest.

The Committee replaces the traditional bi-annual Joint Council which met on a bi-annual basis. It acts as an advisory committee to each respective Council and has no decision-making powers. The Committee will recommend to individual Councils, consideration of intermunicipal cooperation in the following areas:

- Regional sustainability planning (economic, environmental, social, and governance),
- Development of a Regional Recreation, Parks, and Culture Master Plan,
- Regional economic development strategies,
- · Regional citizen engagement,
- Development of a regional "voice" to lobby Federal and Provincial Governments or other agencies regarding matters of mutual interest.

The Committee includes seven members – three members from the County and one member from each of the towns and villages.

Mandate:

Advise and recommend to individual Councils on matters of mutual regional interest.

Family and Community Support Services -Tofield & Beaver County West (FCSS)



Overview:

The Family and Community Support Services (FCSS) program is a joint Provincial (80%), municipally (20%) funded program. FCSS programs are preventive in nature, and promote and enhance the social well-being of individuals, families, and communities. The goal is to help individuals adopt a healthy lifestyle, improve quality of life, and build capacity to prevent crisis. The success of the program is dependent on community resources and volunteers. FCSS programs are based on local decision-making. It is recognized that communities are best able to identify needs and allocate resources appropriately. The Board consists of one member of Council and one public-at-large member.

Mandate:

Tofield & Beaver County West's Vision is "Alberta's diverse people building strong communities through positive, caring interaction and mutual respect".

Its Mission is "... to enhance the quality of life of the residents, through the development of preventative programs and services designed to encourage volunteerism, promote well being, and strengthen the individual, family, and community".

Its Aim is "... to assist the community in innovative planning to meet social needs. Projects will be designed to develop community awareness and resources to strengthen and preserve human initiative and to preclude family or individual breakdown.

- Continue to create awareness of FCSS Youth Programming in the Community
- Poor Economic conditions have caused an increase in poverty & accessibility to programs for Seniors, families and individuals.
- Continue to create partnerships with other human services organizations to offer preventative social service programs in the areas of Tofield &Beaver County West

Highway 14 Regional Water Services Commission



Overview:

The Highway 14 Regional Water Services Commission recently purchased a waterline from CU Water Limited that transports potable water to 1250 customers over a distance of 130 kilometres from Sherwood Park to Kinsella. The Commission also owns water distribution facilities in Ryley, Holden, Bruce, Kinsella, Roundhill, and Kingman. Commission serves 1100+ customers with the Truckfills.

The Directors include one elected official from each of the member municipalities, for a total of 5 members.

Mandate:

The Commission shall supply treated water services to all member municipalities that are connected to water lines operated by the Commission, and to any additional municipalities and non members, to whom the board of directors of the Commission from time to time decides to supply treated water services.

Tofield Municipal Library



Overview:

The Tofield Municipal Library provides library services to residents of the Town of Tofield and the rural Tofield area. Core services include collections and lending services, information technologies, reference and information services, children's services, and learning support and community information services. The library also acts in a supporting role as a community information and activities centre.

Mandate:

The Tofield Library Board's Vision is "Constantly strive to provide excellent public library services with access for all".

The Board's Mission is "Tofield Municipal Library opens a gateway to knowledge, entertainment, and lifelong learning. It makes our community a better place to live".
