#### 5.3. AHS Update

- The transfer truck has not been utilized due to inadequate staffing during the summer. AHS is very aggressive at hiring new recruits and offering full time positions. The next quarterly meeting with the contract team is September 13, 2023.

#### 5.4. Accreditation Update

- There was a team meeting with the Accreditation Canada specialist, Beaver is on the right track for the December visit. The staff have completed their surveys, and the board surveys were reviewed and completed as a group at the meeting, Mr. Baerg will populate them on the website.

#### 5.5. Quality Improvement and Safety/Complaints and Commendations

- The transport ventilators need being replaced as a quality improvement project, the paramedics report an inability to set the ventilators in a safe way.
- -There were two commendations from patients.

#### 5.6. Vehicles and Equipment

- The LP15 cardiac monitor in the second ambulance in Tofield is due to be replaced this year, there was a partial funding grant from CN, the cost would be \$30,727.86 plus GST. There is not currently enough money in the equipment reserves, the station reserve has more than what is needed. Mrs. Stevenson recommends moving allocations from station reserves into equipment reserves to fund the purchase.

**Topic:** FORTIS – Street Light Upgrades

#### **DISCUSSION:**

Recently, Mayor and Council agreed by Motion to have FORTIS place 98 additional light posts in the community. Further, this piece was identified and discussed during the strategic planning session(s). The rationale was to increase lighting canopy, increase lighting exposure to mitigate theft, and overall general safety. As proposed this project was more than \$300,000, being borne by FORTIS with financial obligation to the Town of \$14,000.

In preparation for the project, surveying throughout the community was undertaken by FORTIS, as is evident with staking and flagging. As this has taken place, the Town has received multiple social media messages, phone calls, as well as in-person visits. Feedback from residents has not all been positive. Some individuals do not want the lighting placed near their properties, and many do not want to have overhead servicing.

Given this feedback, Administration has met with FORTIS representatives to discuss project options, pricing on options, and better communication strategies. At current the project is in a state of pause, until further details can be provided. Of interest, having the underground servicing provisions could increase the project cost by an additional \$300,000 of which would be at the Towns cost.

### EXTERNAL AND INTERNAL COMMUNICATIONS/PARTICIPATION:

Should Council approve the recommended motion, communication would be required with the individual property owners. This communication would take place through a combination of in person visits, as well as door knockers. Further, there should be a media piece prepared to discuss the project, as well as to identify perceived project inaccuracies.

#### FINANCIAL IMPLICATIONS:

The costs to have underground servicing provided, would change the project significantly, posing an increase in monies required by the Town.

#### **ALTERNATIVES:**

- 1. Council decisions terminating the project.
- 2. Council decisions moving forward with the project as originally proposed.
- 3. Council chooses to stage the project, in quadrants for the community.
- 4. Council chooses to stage the project, in quadrants with underground power.
- 5. Council pauses the project until actual costs for burying lines are obtained.
- 6. Council denies the proposal & suggest an alternate approach.

#### **RECOMMENDED ACTION:**

Recommendation is being made that Council provide a motion stating:

Council for the Town of Tofield moves the project be paused until costs are provided for the presence of underground power, instead of overhead lines.

### <u> Tofield Lighting Project – Notes on underground service</u>

The total project cost for 98 new streetlights, based on wooden poles, metal streetlight arms and overhead line service is \$311,944, with the Town contributing \$14,182. Based on a cursory review, migrating this project to underground line service will add a minimum of \$400,000 to \$500,000 in costs.

- To estimate the additional cost will require approximately 25 hours of additional work. In part this work is required to re-calculate the voltage drops between each light.
  - Underground service requires a heavier cable. This impacts voltage drops and may require re-design of the circuits from which the lights are fed, to ensure reliable service.
- Underground service is installed through two methods: directional drilling and open trench. Using the open trench method is disruptive, and the ground needs to be returned to its previous state. Directional drilling is less disruptive, but the costs for directional drilling are 5-7x higher compared to open trench. Directional drilling will be required for road crossings.
  - If there are multiple driveways in a particular run, the option for open trench will not be available too difficult to set-up both open trench and direct drilling
- Given resident's concern regarding streetlight poles, etc. underground service may result in greater objections from customers.
- If underground line service is selected, and the project is spread out over a number of years, each stage of the project will be quoted at current rates.
  - Subject to inflationary pressures
- With the additional expense associated with underground, would it be worthwhile to increase the investment and move to steel light poles?

#### **RE: Supporting Watershed Management for a Thriving Town of Tofield**

I hope this letter finds you in good health and spirits. I am writing to you on behalf of the North Saskatchewan Watershed Alliance (NSWA) to kindly request your support for the NSWA in 2024. Last year, Tofield **was not among the more than 40 municipalities who supported the NSWA**. This year, as we embark on another year of collaborative efforts, we are again asking for positive consideration by you and your Council in 2024 for a **contribution of \$1,165.20**.

As you are aware, water and environmental management stands as a pillar of Tofield's growth and prosperity. The well-being of our citizens and our economy depends on secure access to clean drinking water, the sustained health of our watershed, protection against flooding and drought, and effective stormwater management.

Tofield is important to our watershed because the town sits on a tributary to Beaverhill Lake and borders the Beaverhill Lake Heritage Rangeland Natural Area, which means that the water and natural assets in and around the town are important to our watershed's overall health. The water Tofield uses comes from the landscape upstream, while the town's stormwater or wastewater can affect the ecosystem downstream. This means that improving sustainability is best achieved at a watershed scale and in collaboration with other water managers.

At the NSWA, we believe the complex, multi-faceted nature of water and environmental management is best tackled by bringing people and communities together to collaborate. For more than 23 years, the NSWA has worked tirelessly to bring partners together to improve how we collectively manage our rivers, wetlands, and lakes using the best and most applicable science. This important work is accomplished because of the generous support of municipalities like Tofield, the provincial government, and water utilities.

The goals of the NSWA and the Town of Tofield are well aligned. The Tofield Municipal Development Plan sets a goal (#17.3) to ensure that development does not unduly impact the natural environment. The NSWA is working with partners to implement the Integrated Watershed Management Plan for the North Saskatchewan watershed and provide tools and information to municipalities aimed at improving planning and reducing development impacts.



Your support means that the NSWA can continue to bring municipalities and partners together to address water quality and quantity challenges, build new tools for decision-makers, and improve our understanding of the watershed. One such project is the NSWA's update to the State of the Watershed assessment, last completed in 2005. NSWA is using an internationally recognized method called the Freshwater Health Index developed by Conservation International to calculate a numeric rating for the watershed's vitality, ecosystem services, and governance. The State of the Watershed enables Tofield to make decisions and set priorities armed with the best information on the health of the watershed. The assessment is also a valuable tool for the town to communicate basin health with its citizens.

We believe that through collective efforts, we can build a future where water resources are managed sustainably, benefiting not only Tofield but our entire watershed. 

# STATE OF THE WATERSHED ASSESSMENT

The State of the Watershed assessment examines numerous aspects of watershed health so that we have a baseline from which to determine if actions are needed to improve watershed health.



Building upon the NSWA's 2005 assessment, the State of the Watershed will make use of an internationally recognized methodology called the Freshwater Health Index (FHI), developed by Conservation International. This will be the first use of FHI in a North America. The index scores watershed vitality, services, and governance to create scientifically supported, scalable, consistent results that integrate available data and the expertise of local stakeholders, subwatershed alliances, and the NSWA.



#### WETLAND STRATEGY

The NSWA is developing the Strategy to Improve Wetland Management for the North Saskatchewan River in Alberta. This collaborative strategy is intended to coordinate and align the work of partners across the watershed to advance wetland management and implementation of the Alberta Wetland Policy. The NSWA is offering a Wetland Education Sponsorship to support municipal partners as they elevate their knowledge and technical capacity to conserve wetlands and implement wetland restoration initiatives in the watershed.

### **RIPARIAN HEALTH ACTION PLAN**

The NSWA continues to promote practices and policies that support riparian health. We initiated a **review of riparian regulations for 24 municipalities** as a foundation for building a **Riparian Regulations Best Management Practices Guide**. As well, we are working to add new dimensions to the provincial riparian setback calculator to support municipal planning processes. The **Riparian Web Portal** (riparian.info) continues showcase restoration projects from across the watershed.

#### **EDUCATION AND OUTREACH**

A key role for the NSWA is sharing knowledge and information on the North Saskatchewan River watershed. Staff attend community events throughout the summer, publish a monthly newsletter, hosts workshops and webinars, and is actively growing our social media network. We are proud to say we have engaged with more than 1,900 community members and reach over 5,700 people through our social media channels in 2023.

### TOWN OF TOFIELD

A Municipal Corporation in the Province of Alberta (hereinafter referred to as the "Town")

-and-

#### TOFIELD AGRICULTURAL SOCIETY

(hereinafter referred to as the "Society")

WHEREAS the Town is a municipality incorporated pursuant to the provisions of the *Municipal Government Act*, R.S.A. 2000, c. M-26, as amended (the "MGA");

AND WHEREAS the Society is an Agricultural Society incorporated pursuant to the provisions *Agricultural Societies Act*, R.S.A. 2000, c. A-11, as amended (the "ASA");

**AND WHEREAS** the Town values the role of the Society in promoting, encouraging, developing and sustaining an affordable level of quality recreational and cultural services within the Town for the health, benefit, and overall well being of Town residents, including but not limited to Tofield Western Days and the Ry-Tof Slo Pitch Tournament;

AND WHEREAS the Town owns lands located within the Town legally described as:

PLAN 5457AH BLOCK FIFTY FIVE (55)

EXCEPTING THEREOUT: ALL THAT PORTION SHOWN COLORED PINK ON PLAN OF GAS PIPELINE RIGHT OF WAY AS PLAN 709HW, CONTAINING 0.0004 HECTARES (0.001 ACRES) MORE OR LESS 1.3.3 HECTARES (3.23 ACRES) MORE OR LESS UNDER PLAN 3736TR 1.94 HECTARES (4.79 ACRES) MORE OR LESS AS SHOWN ON ROAD PLAN 8321493 PLAN 8920460 ROAD 0.048 HECTARES (0.12 ACRES) MORE OR LESS EXCEPTING THEREOUT ALL MINES AND MINERALS

(hereinafter referred to as the "Lands");

**AND WHEREAS** the Town and the Society entered into a Lease Agreement, dated December 15, 1971, whereby the Town leased the Lands to the Society for a period of 99 years for a cost of ONE (\$1.00) dollar (the "Lease Agreement");

AND WHEREAS the Society owns and operates an arena building (the "Society Building") which it constructed on the Lands;

AND WHEREAS the Town and the Society both believe that the cost to develop, maintain and sustain quality affordable recreational and cultural services for Town residents is a shared responsibility within the community and among members of the community, community volunteers, the Town and surrounding area;

AND WHEREAS the Town and the Society have cooperated in the provision of certain services related to the Society's operations and the Society Building and wish to enter into this Agreement to acknowledge and formalize those arrangements;

**NOW THEREFORE** in consideration of the covenants of each of the parties hereto, and for other good and valuable consideration, the sufficiency of which is hereby acknowledged, the Town and the Society hereby covenant and agree as follows:

- 1. The preamble to this Agreement is incorporated herein.
- 2. The Society covenants and agrees to operate and maintain the Society Building solely for the purposes of developing, maintaining and sustaining quality affordable recreational and cultural services for Town residents, which includes ensuring that the Society Building is at all times open and available to the public subject to normal operation hours and reasonable management practices.
- 3. The Society shall maintain the Society Building in a reasonable state of repair and keep the Society Building in an orderly, clean and safe condition by carrying out necessary maintenance, in accordance with the standards of a prudent owner and, in any event, in accordance with any standards established by the Town for the maintenance of public facilities from time to time.

- 4. In consultation with the Town, the Society shall operate and manage the Society Building in a safe, efficient and good workmanlike manner and not cause or allow any activity on the Lands in contravention of any applicable laws, regulations or bylaws.
- 5. Except as otherwise provided for herein and as may be expressly agreed upon in writing by the Town from time to time, the Society shall be solely responsible for all costs associated with operating and maintaining the Society Building.
- 6. The Town will use its best efforts to provide reasonable support to the Society in the form of funding, materials, equipment and equipment operators, to the extent such resources are not otherwise required by the Town for its own purposes.
- 7. The Town agrees to provide two (2) equipment operators to the Society from October 1 to March 31 (six months) of each year during the currency of this Agreement, in consideration of which, the Society agrees to pay the Town an amount equivalent to the equipment operator's remuneration, including the cost of the equipment operator's salary and benefits, which salaries, along with the cost of benefits, may increase, or decrease, over time.
- 8. In addition to the foregoing, the parties may negotiate the provision of additional equipment operators to the Society by the Town as may be required from time to time for the operation of the Society Building and the provision of services by the Society, on such terms as may be agreed upon by the parties, acting reasonably.
- 9. The Town's obligation to provide equipment operators to the Society is subject to such equipment operators being in the employ of the Town and, despite the Society contributing to the cost of the equipment operator's salary and benefits, such equipment operators shall be directed and managed by and report to the Town. The Town may, in its sole discretion, seek input from the Society with respect to the direction and management of the Town's employees.
- 10. The Town agrees to provide administrative support to the Society in the nature of management and operation of the Society Building and the services provided by the Society. The Society, therefore, agrees to pay the Town ELEVEN THOUSAND (\$11,000.00) DOLLARS per year as a contribution towards administrative salaries, and as an acknowledgement of the administrative support provided by the Town to the Society.

The parties agree to revisit the level of administrative support provided by the Town and the Society's contribution towards administrative salaries regularly to ensure the purposes of this Agreement are being adequately served, both parties acting reasonably.

- 11. In the event that the Society's costs and expenses with respect to the operation and maintenance of the Society Building exceed the revenues generated by the Society Building and any other funding or donations received by the Society with respect to the operation and maintenance of the Society Building, the Society may submit a request in writing to the Town for additional funding and Town will use its best efforts to provide reasonable support to the Society. The Society acknowledges and agrees that any request shall be subject to approval of Council for the Town, in its sole discretion.
- 12. The Town shall not be liable to the Society for the Society Building being located on the Lands, or any thing arising from, related to or consequential to this Agreement. The Society acknowledges and agrees that the Society Building has been constructed on the Lands at the Society's own risk and that the Town shall not be liable for anything related thereto including waste, unjust enrichment or any loss or damages suffered by the Society.
- The Society shall not expand, add to, or conduct any major renovations to the Society Building, without first obtaining the approval of the Town in writing.
- 14. Upon dissolution of the Society, control, maintenance and operation of the Society Building shall automatically revert to the Town.
- 15. The Society shall be governed by, subject to, and shall comply with the ASA and all applicable regulations passed pursuant thereto.
- 16. This Agreement shall commence on the date of execution of this Agreement and shall continue in full force and effect until termination of the Lease Agreement.
- 17. The Society hereby indemnifies and saves harmless the Town, and its employees, agents, servants, volunteers, elected representatives, officers, officials, and representatives from and against all claims, proceedings, actions, costs, expenses, damages and demands in respect of or related to the Society Building and the services provided by the Society, or anything arising from or connected to this Agreement, including, but not limited to, any

death, injury, loss or damage to person or property howsoever caused, including legal costs on a solicitor and his own client basis.

- 18. The Society shall maintain insurance, either directly or through the Town, in regard to the Society Building, evidence of which shall be provided to the Town upon request. Such insurance shall include the following:
  - a) Fire and all-perils risk insurance in such amounts as are sufficient to provide coverage for the replacement cost of the Society Building and such contents as may be owned by the Society, or for which the Society is otherwise responsible;
  - b) Comprehensive general liability and owner's liability insurance in an amount not less than FIVE MILLION (\$5,000,000.00) DOLLARS per occurrence against bodily injury or property damage, including the loss of use thereof. The Town shall be added as a named insured under the policy.
  - c) Such further or other insurance as the Society may deem necessary or appropriate.
- 19. All previous operating agreements between the Town and the Society are hereby terminated and superseded by this Agreement.
- 20. This Agreement shall enure to the benefit of, and be binding upon, the parties hereto and their heirs, successors, representatives and permitted assigns.
- 21. This Agreement may not be assigned, in whole or in party, by either of the parties, without the written consent of the other, which consent may be arbitrarily withheld.
- 22. Each of the parties shall, upon the reasonable request from the other, make, do, execute or cause to be made, done, or executed all such further and other lawful acts, deeds, things, documents and assurances of whatsoever nature and kind for the better or more perfect or absolute performance of the terms and conditions of this Agreement.
- 23. This Agreement may only be altered or amended by written agreement signed by the parties hereto.
- 24. This Agreement may be executed in counterparts, each of which when so executed shall constitute an original and all of which together shall constitute one and the same

Agreement, which shall be sufficiently evidenced by either such original counterpart. This Agreement may be executed and delivered electronically.
